

## Instructions to Authors

---

Submit the manuscript as two hard copies and on a personal computer disk. Manuscripts must be written in English and typed double-spaced including references, size A4 with a margin of 5 cm. The text should normally be divided into Abstract (from 200 to 250 words), Introduction, Materials and Methods, Results, Discussion, Acknowledgements, References, Summary in Lithuanian, Tables and Figure Legends. Key words should be indicated after Abstract.

Submission of a paper will be held to imply that it contains original unpublished work and is not being submitted for publication elsewhere. All the papers will be reviewed. Any manuscript which does not conform to the below instructions may be returned for the necessary revision.

No formal limit is set for the length of a paper, but the editors may recommend condensation where appropriate.

Text in the abstract (200–250 words) must contain all parts of the paper including the key words.

All names, including those of authors, should be written in original language.

Methods of all biomedical studies should meet the requirements of bioethics.

### TITLE PAGE

The title page should contain (a) the title of the article; (b) the first name, initials of other names, and the last name of each author (no academic degrees); (c) name of department(s) and institution(s) to which the work should be attributed; and name and address of author responsible for correspondence about the manuscript.

### REFERENCES

Number references consecutively, in the order in which they are first mentioned in the text, by arabic numerals in parentheses (1). The titles of journals should be abbreviated according to the style used in Index Medicus. For references to manuscripts accepted but not yet published, designate the journal and add (in press). Information from manuscripts submitted but not yet accepted should be cited in *the text* as (unpublished observations).

Present all references in original language.

Numbers of references above 15 should be avoided.

List all authors when six or less; when seven or more, list only the first six and add et al.

### ILLUSTRATIONS

Submit 2 complete sets of figures (one of which must be original) professionally drawn and photographed. Preferably sharp, glossy **black-and-white** photographic prints, of the ready-for-print size. Diagrams and sketches should be in a state suitable for direct reproduction. When symbols, arrows, numbers or letters are used to identify parts of the illustrations, identify and explain each one clearly in the legend. Each figure should have a label pasted on its back indicating number of the figure and names of the authors. The top should be indicated. The legends should be typed on a separate sheet.

### ABBREVIATIONS

Any non-standard abbreviations (to be avoided if possible) should be properly defined in the text the first time they are used.
